Dissertation Abstract

My dissertation is a rehabilitation of patriotism. The initial theory-building is intended to correct for the often vague or empirically unsupported characterizations of patriotism on offer; I draw on scholarship on nationalism, historical research and prominent cultural artefacts to capture an empirically grounded view of patriotism. In particular, I argue that patriotism is not analogous to personal cases of loyalty given that it rests upon a common identity and an intergenerational entity; it is a collective form of loyalty that requires collective self-understanding. Moreover, I argue that patriotism is predominantly cultural rather than political as loyalty and identity predate and survive regime changes. In the final chapter, I address various criticisms of patriotism leading to the central criticism: it is an 'excessive' form of partiality incompatible with universal morality. I raise a dilemma to demonstrate that any 'impartial standpoint' purporting to determine which forms of partiality are morally acceptable is doomed to fail. Either the standpoint is truly impartial, in which case it incorporates no controversial moral claims, and it amounts to mere formalism or the standpoint does incorporate controversial normative claims allowing it to provide substantive criticism, which amounts to begging the question in favour of whichever commitments are incorporated.
